**Educational Notification**

The enrolled candidates who attended the scheduled Offline Round-3 (MoP UP Round) of Tripura State NEET PG 2023 counseling held on 30-09-2023 and are not holding any seat of AIQ or State Quota (except participating for upgrading from a state quota seat only) are invited again to attend the revised continuation of the Round-3 of Tripura State NEET PG 2023 counseling which will be held on **07-10-2023 at 1pm.**

The revised Schedule of the counselling is given below.

1. **Schedule of offline Round-3 Counselling:** Revised continuation of Offline Round-3 Counselling will be held at **Karl Landsteiner Auditorium**, Agartala Government Medical College (AGMC), Agartala at **1 pm on 07-10-2023**. The candidates are instructed to attend the counselling at least one hour prior to the counselling and put their signature on attendance register. Once counselling starts no candidate will be allowed to enroll his/her signature in the counselling even though the candidate already signed on 30-09-2023.
2. The Participating enrolled Candidates are also advised not to leave the counselling room before completion of the counselling even if after allotment.
3. An allotted candidate shall have to report at the office of Directorate of Medical Education at Bidurkarta Chowmohani, Agartala on 09-10-2023 with necessary executed bond. The candidates are also instructed to bring the photocopies of all original documents and 4(four) nos. of passport sized photographs.
4. **Nomination** will be issued on **09-10-2023** to the intending allotted candidates following submission of necessary documents and bond.
5. **Admission** of nominated candidates in the allotted Institution following physical verification of original documents (which will be conducted by the

admitting institution) is scheduled from **09-10-2023** to **10-10-2023** up to **5 pm**.

**6. Last date of joining to a Round-3 nominated and allotted seat is on 10-10-2023 up to 5 pm.**

7. The allotted candidates seeking admission shall have to execute and submit necessary applicable bond (Service bond before getting nomination and Discontinuation bond during admission).

8. The candidates are instructed to follow the DME websites regularly for updates, further notifications etc.

9. In case of any doubt/dispute, the information in respect of the above-mentioned subject matters as provided in respective regulations/ notifications of the concerned Regulatory bodies shall be considered as authentic and final.

Notwithstanding anything contained in the information bulletin or subsequent notifications published in respect of the state NEET PG 2023 counselling, the decision of MCC/NBE/MoH&FW/NMC/MCI/DGHS/Tripura State NEET PG 2023 Counselling Committee/Health & Family Welfare Department, Govt. of Tripura shall be final and binding in respective clauses/Terms/Guidelines as relevant and connected.
