

Fee comprises of Admission Fee, Program Fee, Caution Deposit (Refundable) and Hostel Fee as per the details mentioned below:

Admission Fee: All candidates have to pay an Admission Fee of ₹ 20,000 towards the confirmation of admission.

Program Fee: Students should pay the fee mentioned in the table below at the beginning of each semester as per the due dates indicated in the Student Handbook.

Additional Fee:

Student Activity Fund: ₹1,500 to be charged in the 1st year 2nd semester (One-time payment)

Alumni Fee: ₹1,000 to be paid in two installments (₹500 each) by the final year students in their last 2 semesters.

(Note: Student Activity Fund and Alumni Fee will not be applicable for certificate programs.)

Hostel: Hostel facility is available within the campus. Students will be required to pay the hostel fee as mentioned in the following table:

Respected sir,

I hope this letter finds you well. I am writing to propose a solution like last year for the SC and ST economically weaker students who were not selected for ANM course to government nursing schools.

Last year, your office had approved my request and send 20(Twenty) Nos. of students to our institute but many of these deserving students faced significant challenges in securing admission due to issues such as limited mobile network access and other infrastructural barriers and only few students able to take admission.

In light of this, we at Sarvodaya Institute of Nursing would like to offer our support by admitting these students to our institution. We propose to complete the counselling process for these students in conjunction with the government nursing institutes to ensure a seamless and equitable admission process.

Our proposed terms and conditions for this initiative are as follows:

- Eligibility Criteria:** Only SC ,OBC and ST students from economically weaker sections who were not selected for government nursing schools will be considered.
- Counselling Process:** The counselling process will be conducted in collaboration with the government nursing institutes to ensure transparency and fairness.
- Fee Structure:** We will not charge any fees from students. We will charge only those fees which govt. institute do.
- Academic Support:** We will provide additional academic support and resources to help these students succeed in their studies.
- Monitoring and Evaluation:** Regular monitoring and evaluation will be conducted to ensure the academic progress and well-being of the students.

With your support, we can provide these students with the quality education and training they aspire to and deserve. This collaboration will promote inclusivity and uphold the principles of equity and social justice.
