MOP UP ROUND(OFFLINE) OF TRIPURA STATE NEET UG 2021 COUNSELLING

The MOP UP Round (Offline) of Tripura State NEET UG 2021 Counselling will be held at “Karl Landsteiner Auditorium”, Agartala Government Medical College & GBP Hospital, Agartala on 5th April, 2022(Tuesday) at 1-00PM.


Only Registered Candidates of Round 1 and / OR Round 2 of Tripura State NEET UG 2021 Counselling who have not been still admitted to a Seat in any Round 1 OR Round 2 of All India Quota, Tripura State or any other NEET UG 2021 Counselling and not allotted to any Seat in MOP UP Round of All India Quota NEET UG 2021 Counselling will be eligible for the MOP UP Round of Tripura State NEET UG 2021 Counselling.

The Candidates who have surrendered any admitted Round 1 State Quota Seat within the Scheduled last date of Surrender 19-03-2022 will be eligible for the MOP UP Round. Candidates who did not join an allotted Round 2 State Quota Seat within the stipulated period of admission of Round 2 will be eligible for the MOP UP Round of Tripura State NEET UG 2021 Counselling with forfeiture of Security deposit of Round 2.

There will be no Fresh Registration in this MOP UP Round since there is no information regarding revised (reduced) Cut off Score till date.

Candidates are instructed to bring all the original Testimonials/Documents/Certificates in support of their Eligibility, Qualification, Date of birth, NEET UG 2021 Admit Card & Score Card, Caste Certificate (wherever applicable), PRTC, PwD, EWS Certificate (wherever applicable), Transaction proof/Acknowledgement of Registration Fees and Security Deposit of Round 2(wherever applicable) which will be asked to produce in the Offline Counselling. Failure to be physically present by a candidate or failure to show the original documents or submission of Vague/False/incomplete/eligible/inauthentic relevant documents in the Counselling may lead to cancellation/ rejection of his/her Candidature from participating in the Counselling/ Selection in the Counselling & Nomination/ Admission in respect of the candidate at any point of time on identification of such.
