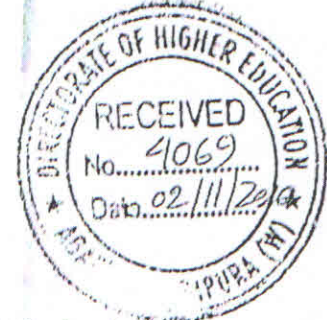


For All India Quota i.e. for 31 seats in each course, separate online centralized counseling will be done by Ministry of AYUSH ([www.aicee.gov.in](http://www.aicee.gov.in)) and 01 seat of Foreign National in each course will be nominated by ICCR.

Candidates who have qualified in NEET 2020, conducted on All India basis by NTA and are desirous of taking admission in NEIAH under North East States Quota (except Assam) i.e. 31 seats have to download the prescribed application format & Information brochure (to be uploaded soon) from the Institute's website [www.neiah.nic.in](http://www.neiah.nic.in). Notice of Admission will be published in leading newspapers of all North Eastern states in due course of time. No nomination/recommendation from the Government will be entertained.

The North East States' aspirants who are willing to apply for All India Open Seats have to apply separately on online Centralized Counselling to be done by Ministry of AYUSH, Govt. of India, New Delhi. Desirous candidates should visit the Institute website regularly.
